

Thank you for your interest in chartering with BBBoats. Ahead of your charter booking, please take some time to review our Charter Terms and Conditions. By booking and proceeding with your charter, you would have deemed to have understood and agreed with the charter terms.

1. The yacht will be available for boarding 20 minutes prior to your charter time. You and your guests are advised to be on time, as no time compensation will be given for late arrival. In the event of a no-show by you and your guests, the charter will deem to have proceeded and no refunds will be provided.
2. We have a barefoot policy onboard our yachts interiors. Guests will be asked to deposit their shoes upon boarding.
3. In line with Singapore's COVID-19 Safe Reopening Phase, there will be check-in/check-out procedures using SafeEntry. Temperatures will also be taken. We regret that guests with temperatures registering 37.5c and above, or who exhibit symptoms such as cough, flu-like symptoms, will not be able to join the charter.
4. With the exception of eating, drinking and engaging in water activities, we request that guests wear a mask. Disposable masks are available on the yacht, if required.
5. In line with government guidelines, recorded music will be permitted as background music up to 60 decibels. Self-service buffet lines, live music, radio broadcasts and all forms of television/video screenings and other forms of entertainment such as dancing, darts or karaoke will not be permitted.
6. Charters will proceed despite rainy weather. If a decision is made by BBBoats to cancel the charter due to inclement weather and sea conditions, the charterer may change the date of the charter to another date, subject to yacht availability.
7. Due to the unforeseen circumstances such as inclement weather, charter itineraries and activities are subject to change. Should weather conditions change and worsen while at sea, please note that activities will be stopped if the safety of guests are at risk and the vessel will return to the marina.
8. There is no designated lifeguard onboard and guests who participate in water activities do so at their own risk. While the surface of waters may appear calm, underlying currents and waves can be stronger than anticipated. Please use the lifevests while engaging in water activities.
9. In accordance with the authorities' regulations and requirements, all charter vessels carry their own limited insurance. Personal accident and life insurance is recommended to be undertaken by the charterer and/or his guests.
10. There are no corkage charges, but because of the possibility of staining, we request that no red wine be brought onboard.
11. Cooking is not permitted onboard, unless otherwise authorised by BBBoats prior to charter date. However, our galley is equipped with a toaster, kettle, refrigerator and microwave onboard for our guests' use.

12. Please smoke only at the designated outdoor smoking areas, and dispose of butts in the provided ashtrays.
13. BBBoats observes a no-pets policy onboard our vessels.
14. BBBoats reserves the right to cancel the charter due to unforeseen circumstances such as vessel breakdown and mechanical issues. In the event of such cancellation, the charterer may change the date of the charter to a mutually-agreed upon date. BBBoats also reserves the right to substitute with another similar vessel and continue with the charter as planned. Charterer agrees to indemnify BBBoats against all claims, losses or damages resulting from the cancellation.
15. All persons on board must follow the instructions of the Captain. The Captain reserves the right to prevent from boarding any person who is unruly or causes nuisance or a danger to himself and other persons on board. The Captain reserves the right to cancel the charter with no refunds if the charterer and/or guests are deemed to act in an unruly and uncooperative behaviour which may endanger himself/herself, crew, guests or the vessel. Controlled substances as defined by relevant laws and illegal substances and items are not permitted onboard our yachts.
16. The Captain shall also have the authority to immediately terminate a charter and return to the marina in situations due to reasonable suspicion of any illegal activities, the use or possession of any and all illegal or illicit drugs, overly and dangerous usage of alcoholic. Where needed, the authorities will be contacted.
17. We strive to provide a yacht that is clean and pleasant for our guests. We respectfully request guests to treat the yacht as they would their own spaces. Any professional cleaning services, that need to be engaged after the charter as a result of guests' use of the yacht may be charged accordingly.
18. To the fullest extent permitted by law, charterer and guests assume all risks of accident, injury, loss of life, and damage to the yacht associated therewith and release BBBoats, and the respective agents, members, officers, directors, employees, licensees, invitees and volunteers and chartered boat owners, (hereafter "Indemnitees") from all liabilities from all damages and claims of any kind whatsoever due to any of the following:
 - a. the failure of charterer and guests to perform or observe their respective obligations under the Agreement;
 - b. the negligence or default of charterer or guests,and charterer and guests shall jointly and severally indemnify and hold harmless the Indemnitees, from and against any and all liabilities, damages, claims, and expenses, that the Indemnitees shall at any time sustain due to the negligence or default of charterer and guests except to the extent that such liability is covered by our insurance.
19. In the event that any of these terms and conditions shall be determined to be invalid, unlawful or unenforceable, such terms, condition or provision shall be severed from the remaining terms, conditions and provisions, and the remaining terms, conditions and provisions which shall continue to be valid to the fullest extent permitted by law.

20. BBBoats reserve the right to make amendments to these terms, but will inform you prior to your charter.
